In the event a claim would be made by any third party, the undersigned individually, and/or as agent of any organization as herein named, agrees to fully cooperate with Kinokawa, and Michael Wirth, and their insurance carriers and any other person or organization designed by Kinokawa and Michael Wirth to investigate and/or defend such claims, and to provide such information as shall reasonably be necessary and/or required.
